Notification

1. The notification (initial notification) dated 04/27/1998 – Pr.2152 lbzb (45/98) – regarding the type approval for the plastic underground cable duct Vario-Tec+ of Size 1, initially renewed with notification dated 10/13/2003 – 21.52 lbzb (0048/03) – is again renewed.

The notification at hand is valid only in conjunction with the aforementioned notifications. All parts of the aforementioned notifications shall continue to apply unless otherwise ruled or supplemented in the notification at hand.

2. Costs

Grounds

In accordance with Section 3 of the Law on the Federal Railway Administration (Bundeseisenbahnverwaltungsgesetz – BEVVG § 3) dated 12/27/1993 (BGBl I, Pages 2378 & 2394) in its currently valid version, the Federal Railway Authority (EBA) is responsible for construction approvals, acceptance inspections, verification tests, the granting of approvals & authorizations as well as for the supervision, erection, modification, maintenance and operation of the operations facilities of the Federal Railways.

Renewal of the type approval was required, since the renewal of the type approval granted with notification dated 05/27/2003 – 21.52 lbzb (018/03) is limited in time until 05/31/2008.

Renewal of the aforementioned notification was again possible, since nothing conflicts with a repeat renewal, taking into account the notification as such.

Fees and costs will be levied in accordance with Section 3 (§ 3) Para, 4 Page 1 of the BEVVG in conjunction with the Ordinance on fees and expenditures for official acts of the Federal Railway Administration (BEGebV dated 04/05/2001 BGBl. I, Page 562) in its currently valid version.

Information on legal remedy

Objection may be filed against the notification at hand within one month after publication.

Objections will have to be filed in writing or put on record with the Federal Railway Authority, Vorgebirgsstraße 49, D-53119 Bonn.

The deadline is also complied with if objections are filed at a branch of the Federal Railway Authority.
