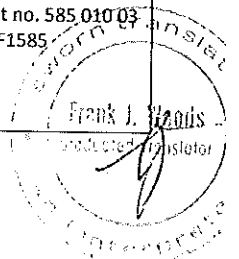

### Decision

1. The decision (initial decision) dated 05/04/1998 – Pr.2152 lbzb (24/98) – regarding the **type approval** for the plastic underground cable duct Vario-Tec+ of Size 2, initially renewed in the form of alteration by decision dated 05/27/2003 – 21.52 lbzb (018/03) – is again renewed.

The decision at hand is valid only in conjunction with the aforementioned decisions. All parts of the aforementioned decisions shall continue to apply unless otherwise ruled or supplemented in the decision at hand.

The decision at hand is limited in time until 05/31/2013.

The costs of the proceedings shall be borne by the applicant. The decision regarding fees and costs will be issued separately.

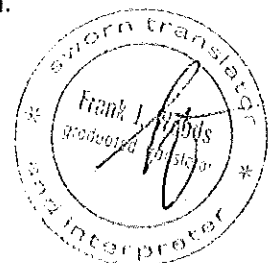
#### Grounds

In accordance with Section 3 (§ 3) of the Law on Federal Railway Administration (Bundeseisenbahnverwaltungsgesetz - BEVVG) dated 12/27/1993 (BGBl I, Pages 2378 & 2394) in its currently valid version, the Federal Railway Authority (EBA) is responsible for construction approvals, acceptance inspections, verification tests, the granting of approvals & authorizations as well as for the supervision, erection, modification, maintenance and operation of the operations facilities of the Federal Railways.

Renewal of the type approval was required, since the renewal of the type approval granted by decision dated 05/27/2003 – 21.52 lbzb (018/03) is limited in time until 05/31/2008.

Renewal of the aforementioned decision was again possible, since nothing conflicts with a repeat renewal, taking into account the decision as such.

Fees and costs are levied in accordance with Section 3 (§ 3) Para, 4 Page 1 of the BEVVG in conjunction with the ordinance on fees and expenditures for official acts of the Federal Railway Administration (BEGebV dated 04/05/2001 BGBl. I, Page 562) in its currently valid version.



**Information on legal remedy**

Objections against the decision at hand may be filed within a period of one month following publication.

Objections will have to be filed in writing or put on record with the Federal Railway Authority, Vorgebirgsstraße 49, D-53119 Bonn.

The time limit shall be deemed to have been complied with also if objections are filed at a subsidiary of the Federal Railway Authority.

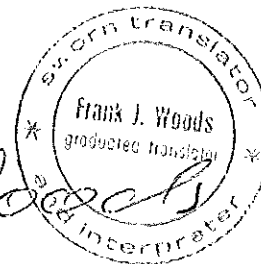
